For the sake of clarity, it is hereby stated that all the above objectives could be carried out for the benefit of the public at large, irrespective of the caste, creed, religion and sex. The above activities will be carried out without any profit motive and only nominal charges, if any, will be levied if required. However, surplus if any arising out of any of the activities of the trust will be reinvested solely for the attainment of objectives of the trust and will not be distributed, either directly or indirectly for the benefit of the trustees. However, nothing herein shall prevent the payment in good faith, of reasonable and proper remuneration to any officer or any member of the trust, in return for any services actually rendered to the trust, nor prevent the payment of interest for money lent are reasonable or proper rent for any premises demised or let by any member of the trust.

FOLLOWING CLAUSE SHALL BE MODIFIED IN THE AIMS AND OBJECTIVES OF THE TRUST AS UNDER:

14. The trustees continue to be the trustees during the time of their natural life, unless they become incompetent to execute contract or resigns voluntarily.

FOLLOWING CLAUSES SHALL BE MODIFIED IN THE LAWS OF THE TRUST:

23) POWERS OF THE TRUSTEES:

Without prejudice to the generality of the powers, the Trustees shall have the following powers:

- i) To employ administrators, clerks and other employees, agents, bankers, accountants and others at such remuneration as they may think fit. To appoint advocates, attorneys and to execute powers of attorney etc., for and on behalf of the trust.
- ii) To delegate powers as they can lawfully delegate to any person and to execute such instruments as they may think fit for the purpose.
- iii) To convert, to call in, to sell or otherwise dispose of any of the investments comprised in the trust property and reinvest or change the nature of any other investment contained therein, to compound and settle any claims against the trust.
- iv) To invest the funds of the trust in such manner as permissible under section 11(5) read with section 13 of the Income Tax Act, 1961 as may be amended from time to time, so as to ensure exemption from taxation.



 - vii) To let any portion of any immovable property forming part of the trust fund at such rent and for such period and on such terms and conditions as they may think fit and accept surrender of any lease.
 - viii) To open, maintain and operate bank accounts and other investments in the name of the trustees as authorized by the Board of Trustees.
 - ix) No business shall be carried on by the Trustee unless such business is incidental to the attainment of objects of the Trust. Separate Books of Accounts shall be maintained by the Trust in case such business is carried on.
 - x) To raise loans on the mortgage of trust properties, movable or immovable.
 - xi) To borrow funds with or without security of the property and for this to hypothecate, mortgage, charge and/or encumber any asset.

24) The funds of the trust shall be invested in the modes specified under the provisions of section 13(1) (d) read with section 11(5) of the Income Tax Act, 1961 as amended from time to time.

25) The funds and the income of the trust shall be solely utilized for the achievement of its objectives and no portion of it shall be utilized for payment to the trustee/members by way of profit, interest, dividends etc.

26) No amendments to the trust deed shall be made which may prove to repugnant to the provisions of sections 2(15), 11, 12, 12A, 13 & 13A & 80G of the Income Tax Act, 1961, as amended from time to time and no amendment shall be carried out without the prior approval of the Commissioner of Income Tax.

27) The benefits of the trust shall be open to all irrespective of caste, creed or religion.

28) The trust formed shall not be revocable.
